### 2018-2019 School Year

Dear Parents or Guardians of New Students:

Welcome to the Wa-Nee Community Schools! As a school community, we are very proud of the educational opportunities that we provide our children. We trust that you will be pleased with the experiences that your children will have while enrolled in the Wa-Nee Community Schools.

In accordance with the Indiana immunization laws (I.C. 20-34-4), when a student enrolls in a school corporation his/her parents must show either that he/she has been immunized or that a current religious or medical objection is on file. Parents must provide the school corporation with complete immunization records prior to the beginning of the school year.

The minimum state vaccine requirements for all children newly enrolled in kindergarten are as follows:

- **DTaP:** 5 DTaP/DTP/DT (Diphtheria, Pertussis and Tetanus) or 4 if the 4th dose was administered on or after the 4th birthday.
- **Polio:** 4 doses - 3 doses of Polio are acceptable for all grade levels if the third dose was given on or after the 4<sup>th</sup> birthday and at least 6 months after the previous dose with only one type of vaccine used (all OPV or all IPV).—For students in grades 1-8, the final dose must be administered on or after the 4<sup>th</sup> birthday and be administered at least 6 months after the previous dose.
- **MMR:** 2 Measles/Mumps/Rubella
- **Hepatitis A:** 2 doses
- **Hepatitis B:** 3 doses of Hepatitis B vaccine (3rd dose must be given on or after 24 weeks of age and no earlier than 16 weeks after the 1<sup>st</sup> dose).
- **Varicella:** 2 doses of Varicella (Chickenpox) vaccine on or after the first birthday or Physician written documentation of history of chickenpox disease, including month and year of disease.

The responsibility of parents in meeting these state immunization requirements is very important in promoting the health and safety of all children within the Wa-Nee Community Schools.

**The kindergarten physical form must be completed and turned in to the school by August 15, 2018. Children not in compliance will not be permitted to start school.** Your cooperation in this matter is greatly appreciated.
